2. **Appointment of Secretary: Jim Ronback** to act as secretary of the meeting.

3. **Determination of Quorum**: In accordance with the current constitution of the Delta

Naturalists Society, Schedule B, 16 (3) a quorum consists of seven members. A quorum is present. President declared that this Annual General Meeting is called and properly

constituted for the transaction of business.

4. **Minutes of the Last AGM:** The last Annual General Meeting of the Delta Naturalists Society was

The Treasurer presented the statement of receipts and disbursements. Ursula Easterbrook moved and Hans-Ulf Schellhase seconded a motion that the statement of receipts and disbursements for the fiscal year ending 31 August

2013 be approved. CARRIED.

6. Election of Directors:

Ken Borrie moved and Jonathan Mwenifumbo seconded that the persons nominated be declared duly elected as directors of the Delta Naturalists Society to hold office until the next annual meeting or until their successors are elected subject to the provisions of the bylaws of the Delta Naturalists Society.

President declared that the nominees are elected as directors of the Delta Naturalists Society to hold office until the next Annual General Meeting or until their successors are appointed in accordance with the bylaws of the Delta Naturalists Society.

7. Annual Fees:

Ursula Easterbrook moved and Jim Ronback seconded a motion that the fees of the Delta Naturalists Society for the coming year be \$30 for individuals and \$40 for family or group memberships and that the fee due date be September 1. CARRIED.
